

# Introducing the Corrections Tab

To give you a clearer, more transparent way to track agency billing and an easier way to approve or dispute charges, we've introduced a brand new Corrections tab in your portal.

+ Catch rate issues before billing closes

+ Approve or dispute in one click

+ No emails back and forth

The Corrections tab brings that entire process into your portal, so you can instantly see what's been flagged and resolve it in seconds.

## The Corrections tab

✓ Full visibility into rate changes before your invoice is finalised.

If an agency flags a charge rate as incorrect, you will see it instantly in the Corrections tab and receive an email link to review it, with a clear view of what needs action.

### ✓ Approve

- You agree the corrected rate is right
- Billing updates automatically
- Agency is notified. Nothing more needed from you.

### ✗ Dispute

- You disagree with the proposed change
- Original rate is kept
- Your account manager follows up to resolve if needed from you.

## Approving or Rejecting Shifts

### ✓ Spot a rate issue before you approve, not weeks later.

Before approving any correction, you'll be shown a full breakdown of the job details and shift information so you can review exactly what's being submitted and why.

This ensures you have complete visibility over any changes that may impact billing or timesheets.

From here, you can review the request, check the shift details, and choose to approve, edit, or reject the correction based on what looks right.

## Timesheet auto-approval for retro jobs

### ✓ One step instead of two.

When an agency posts a job after the shifts have been worked, you used to approve the job and then find and approve each timesheet separately. That extra step is gone.

#### Before

Approve the job, then separately find and approve each timesheet



#### Now

Approve the job → timesheets approve automatically

### Emails you'll receive

## Common questions

### Do I need to do anything if I'm happy with all the rates?

No. In fact, most of the time, rates are correct and agreed by all parties. This new flow is simply a method to handle those rare cases where there's misalignment. So if no corrections have been sent by an agency, there's no action to take and billing will proceed as normal.

### I approved a retro job but can't see the individual times in the corrections tab. Is that correct?

Yes. Timesheets for retro agency jobs are auto-approved when you approve the job. They appear in your timesheets page as approved but will not appear in your corrections tab anymore.

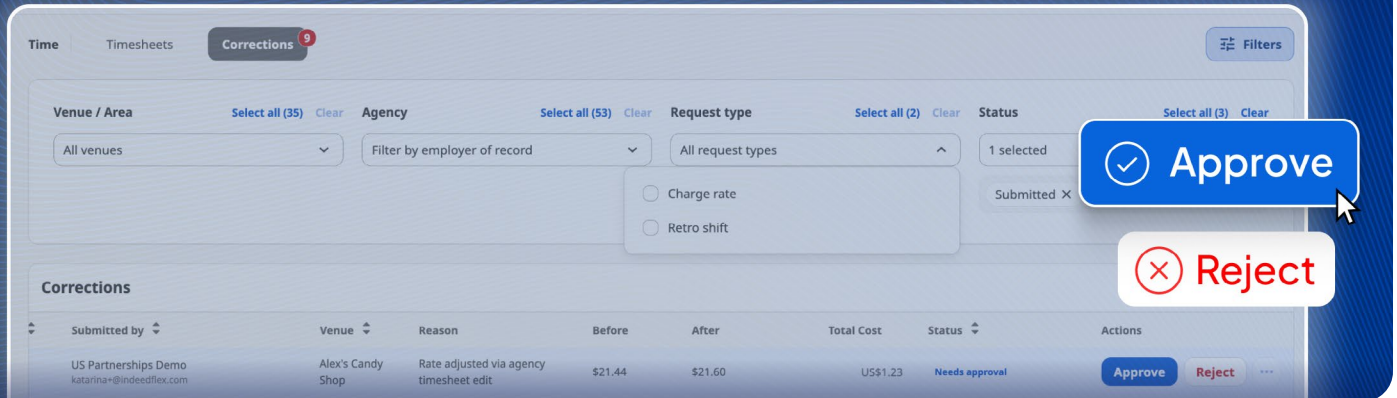
### I approved a retro job but can't see the timesheets. Is that correct?

Yes. Timesheets for retro agency jobs are auto-approved when you approve the job. They appear in your records but not in your approval queue.

### What if I ignore a correction notification?

Unapproved corrections remain in your queue and may delay billing for those timesheets. Your account manager will follow up if needed.
